- 1.1. This Promotion incorporates the ["Alliance Bank HYROX Kuala Lumpur & Merdeka Blind Box Acquisition & Usage Campaign" Terms and Conditions](#), but only in respect of the Eligible Cards listed in Clause 3 below and only for the duration of the Promotion Period specified in Clause 2 below. Any applications received outside the Promotion Period (as may be revised) will not be considered.

3. **Eligible Cards**

4. **Eligibility**

- 5.3. The Organiser reserves the right to approve or reject applications submitted on the website without providing a specific reason.
